

# CONTINUING EDUCATION CREDITS

The Council on Social Work Education (CSWE), provider # 1163, is approved as a provider for social work continuing education by the Association of Social Work Boards (ASWB; www.aswb.org) through the Approved Continuing Education (ACE) Program. CSWE maintains responsibility for the program.

As an ACE provider, CSWE offers continuing education (CE) credits for panels, workshops, and Preconference Development Institutes.. Each session must meet strict standards to



be approved for CE credits. The shortest time interval eligible for the ASWB ACE program is 1 hour, with clearly defined and outlined learning objectives, ending with an evaluative measure. CSWE's status as an ACE provider is contingent on adhering to the standards and requirements of the ASWB. The following five educational session formats meet the ASWB's ACE standards for CE eligibility.

#### OCTOBER 19, CE-ELIGIBLE PRECONFERENCE WORKSHOPS

- Grand Challenge Institute (3.0 CE credits)
- Field Education Institute (up to 3.0 CE credits)
- Leadership Development Institute (3.0 CE credits)

#### OCTOBER 20-22, CE-ELIGIBLE EDUCATIONAL SESSION FORMATS

- Interactive Workshop (1.0 CE credit)
- Panel (1.0 CE credits)

Credit is awarded at 1.0 CE credit per 60-minute session (50 minutes of uninterrupted instruction).

Please note that although ACE provider CE credits are accepted by most U.S. state licensing boards, the final authority for approving any continuing education activity rests with the social work board of the state where you are licensed. Even those states that accept ACE approval may have exceptions in terms of the courses they accept.

#### **Processing Fee**

An additional fee of \$65 is assessed for CE credit processing. This fee covers collecting and organizing



session data, registering and tracking participants, and administering certificates after the APM. Without the CE Passport documentation, your state may not acknowledge your CE credits earned at the APM.

#### **Attendance Tracking**

Attendance is tracked at the beginning and end of each session. To receive proof of attendance, CE participants must scan the earth-friendly bar code (located on each name badge) as they enter and exit CE session rooms. Participant data is stored and used later with the evaluation forms to tabulate CE credits earned and to create the CE certificate. Participants must arrive at the sessions on time and complete the required session evaluation forms, or they will not be eligible for CE credit. CSWE cannot provide verification of attendance after the conference is over.

#### **Certificate Issuance**

Those planning to earn CE credits at the APM may download the session evaluation forms from the CSWE website and complete them after attending a CE eligible session. CE registrants will receive the link to these forms 2 weeks prior to the meeting. Completed CE session evaluation forms can be e-mailed to apm@cswe.org or mailed to Council on Social Work Education, 1701 Duke Street, Suite 200, Alexandria, VA 22314. CE certificates will be transmitted electronically within 30 days of the APM.

#### A GRAND CHALLENGE 4: ADVANCE LONG AND PRODUCTIVE LIVES

### Equipping Social Workers to Promote a Social Development Response to Population Aging

All social workers need to be equipped to mediate the great social transformation signaled by the growing proportion of older adults in society. Attendees will learn strategies for teaching social workers working with any population in any setting to promote a social

This workshop demonstrates ways to incorporate curriculum content related to Grand Challenge 5, Eradicate Social Isolation. #### C GRAND CHALLENGE 6: END HOMELESSNESS

This paper shares the findings of a pilot permanent supportive housing program evaluation for families and young adults based on the best practice Housing First model for single adults. The program provided housing and supportive services to homeless young adults and families with substance abuse and/or mental conditions. Presented by Cyleste C. #### D GRAND CHALLENGE 7: CREATE SOCIAL RESPONSES TO A CHANGING ENVIRONMENT

### Teaching Environmental Justice Across the Curriculum: 2015 EPAS and Beyond

Participants will examine environmental justice and climate change issues, learning ways to integrate education about the complexity of the issues into the classroom and field curriculum. Multiple channels for integrating this material will be explored within the context of the new EPAS. Training will be interactional with resources provided. #### How to Prepare Social Workers to Ensure Healthy Development for All Youths

With many systems aiming to be preventive in their services, training the next generation of social workers to be effective prevention practitioners is essential. This workshop enables educators to explore and apply methods for training micro- and macro-level prevention social workers passionate about ensuring healthy development for all youths. Simulation programs to address three grand challenges—stop family violence, close the health gap, and achieve equal opportunity and justice—will be discussed in detail. To address the Grand Challenges, social work professionals must be fully prepared for transdisciplinary and translational science and practice. Through this interactive institute, faculty members will increase their ability to equip students with these critical skills. This session presents approaches to teaching social work students, teachers, practitioners, and researchers about the centrality and ramifications of extreme economic inequality for practice at all levels—individual, community, policy, management, and evaluation and assessment. We explore multiple approaches, providing materials and opportunities to engage with them. #### J GRAND CHALLENGE 11: BUILD FINANCIAL CAPABILITY FOR ALL

### CBPR: Teaching Research for Engaging Students to Address the Grand Challenges

Community-based participatory research (CBPR) is an interdisciplinary teaching methodology involving students in meaningful research experiences. Data engages students and community partners to address social justice initiatives addressing Grand Challenge themes that close the health gap, create social responses to a changing environment, reduce economic equality, and achieve equal opportunity and justice. #### K GRAND CHALLENGE 12: ACHIEVE EQUAL OPPORTUNITY AND JUSTICE

### Facilitating Minority Scholar Career Development: How to Build an Infrastructure for Success

Presented by the CSWE Center for Diversity and Social & Economic Justice, this FDI is designed for deans and directors, faculty mentors, junior faculty, and doctoral students interested in learning evidence-based strategies to facilitate the early career development of minority scholars, including assessing and strengthening a school's existing infrastructure. ### Managing a Field Education Program: A Training for New Field Directors

In recognition of Carl Anderson Scott's groundbreaking contributions to CSWE and the profession of social work, the Carl A. Scott Memorial Lecture was established to continue his legacy of equity and social justice in social work through building knowledge and furthering the well-being of individuals and their communities. A highlight of the APM since the late 1980s, recent lectures have featured speakers such as Michael Spencer, John Wallace Jr., and Luis Zayas. The 2017 Carl A. Scott Memorial Lecture will be held on **Saturday, October 21, from 8:45 am-10:15 am**. Previously, Dr. Wilder served as director of community pediatrics at Georgetown

University Medical Center and chair of Mobile Health Programs at Children's National Medical Center. She volunteers her time and expertise as a pediatrician at safety net clinics throughout the Washington, DC, region.

A nationally recognized speaker and expert on poverty and economic segregation in health care, Dr. Wilder's work has been featured on *The Oprah Winfrey Show*, CBS' *48 Hours*, and NBC's *Dateline*. In the past two decades, she has received <u>numerous awards</u>, including <u>Washingtonian of the Year</u> in 2015, the Caring Award in 2005 (in company with Jimmy Carter and Mother Teresa), George Washington University Physician Humanitarian of the Year in 2004, and *The Oprah Winfrey Show's* Angel Network <u>Use Your Life Award</u> in 2002.

Dr. Wilder received her bachelor of science degree from Howard University, her doctor of medicine degree from Georgetown University, and earned her masters of public health at George Washington University.

# CSWE 2017 Professional Recognition AWARDS

#### Significant Lifetime Achievement in Social Work Education Award

The Significant Lifetime Achievement in Social Work Education Award is presented to **Dr. June Hopps**, Thomas J. Parham Professor, Graduate School of Social Work at the University of Georgia.

Dr. Hopps has dedicated her life to issues of race, inequality, social justice, and human and civil rights. She is a leading authority on public policy for children and families and was instrumental in establishing the Donald L. Hollowell Professorship at the University of Georgia along with other initiatives. Dr. Hopps was the first African American to serve as dean at the Boston College Graduate School of Social Work and as editor-in-chief of NASW's journal, *Social Work*.

An iconic leader, historical figure, and social change agent in social work and social policy, Dr. Hopps' career is distinguished by activism through community and scholarly engagement to dismantle racist, oppressive beliefs and practices in social service and other realms. This activism is reflected in Dr. Hopps' eminence as a policy scholar and her prolific, transformative, antioppressive scholarship including her book, *Social Work at the Millennium: Critical Reflections on the Future of the Profession* and articles focused on race, social justice, civil rights, and the social work profession.

Dr. Hopps has provided tireless leadership, mentorship, and service over the course of her career, including during her 24-year tenure as dean at Boston College, where she is credited with fostering the growth and excellence of the Graduate School of Social Work. She has served on numerous university, community, and governmental boards, committees, and commissions, lending her public policy expertise to bridge the gap between the academy and public services.

Dr. Hopps is the recipient of numerous awards for her leadership and contributions, including NASW's award for Outstanding Leadership in the Social Work Profession, the establishment of the June Gary Hopps Graduate Fellowship at Boston College, and the proclamation of June Gary Hopps Day by the state of Massachusetts.

#### Distinguished Recent Contributions to Social Work Education Award

The 2017 Distinguished Recent Contributions to Social Work Education Award is presented to **Dr. Kathryn Collins,** associate professor at the University of Maryland School of Social Work.

Dr. Collins' accomplishments in research and scholarship, pedagogy, curriculum development, and organizational leadership are impressive. She focuses on social justice; disparities in access to trauma-based mental health services; and the development of interventions for vulnerable and oppressed children, women, and families living in poverty and experiencing inner city violence. She has more than 19 years of practice experience with children and families. This experience has influenced her research such that she has been the principal investigator (PI) or co-PI on state and nationally funded research on mental health. She received an extramural research award from the National Institutes of Health's National Center for Minority Health and Health Disparities. She is currently a co-PI on a Substance Abuse and Mental Health Services Administrationfunded National Child Traumatic Stress Network Family Informed Trauma Treatment Center project, and a PI on

the Trauma Education Connections Initiative. She is a co-developer of a trauma-informed intervention, Trauma Adapted Family Connections. She has authored 23 publications, six book chapters, and several conference presentations.

Dr. Collins brings practice and research experience to the classroom and has received teaching awards that include a letter of recognition at the University of South Carolina, the Provost's Teaching Excellence Award at the University of Pittsburgh, and a Dean's Exemplary Teaching Award at the University of Maryland. She has contributed to the pedagogy and curriculum development at the University of Maryland, including the development and teaching of trauma skills courses. Dr. Collins serves on the Student Review and Faculty Executive Committees and previously served on the Faculty Senate, the Human Subjects, Master's Program, Field Education, Clinical Concentration, and the Vice President Search Committees. She serves on the National Child Traumatic Stress Network's Core Curriculum in Trauma Treatment and CSWE's Core Competencies in Trauma taskforces. Previously, she served on CSWE's Council on the Role and Status of Women in Social Work Education. For her work with CSWE she has received awards for mentoring and leadership.

### Service and Leadership in Social Work Education

The Service and Leadership in Social Work Education Award is presented to Dr. Phyllis Black, MSW, PhD, ACSW, LSW. Dr. Black's leadership and service have expanded our thinking about the nature of education for social work

practice with integrity, substance, and commitment.

Having received her BA and MSW at McGill University and her doctorate from the National Catholic School of Social Services, Dr. Black has taught for the past 50 years. She has a passion for serving by educating future social workers and mentoring current social workers. Dr. Black's leadership as chair of the CSWE Commission on Curriculum and Educational Innovation resulted in the important shift from a content to a competency-based framework for social work education in the 2008 CSWE Educational Policy and Accreditation Standards (EPAS). She has published extensively, particularly in the areas of ethics in social work practice.



Dr. Black's scholarship is focused on ethics in social work practice and issues related to social work education. She is a member of the NASW PA Committee on Ethics and served three terms on the CSWE Board of Directors. As a member of the CSWE Commission on Accreditation, she participated in drafting the standards for the 2015 EPAS. Dr. Black has received Outstanding Teaching Awards from Catholic University and Chestnut Hill College, the Marywood University Distinguished

Faculty Award, a Distinguished Alumna Award from Catholic University, the NASW Lifetime Achievement Award, and is a Social Work Pioneer.

#### Mildred Carter Joyner,

West Chester University of Pennsylvania (Emerita)

The Service and Leadership in Social Work Education Award is presented to Mildred "Mit" Joyner. Throughout her professional career, equality and justice for all has been Joyner's core mission, best

exemplified in her leadership and service to advance social work education.

Joyner began teaching in 1978 at West Chester University of Pennsylvania (WCU), becoming director/ chair of the department in 1981, and taught social work courses for more than 29 years. In her leadership role as director, she was the catalyst in the development of the MSW program, the first accredited MSW program in the Pennsylvania State System of Higher Education.

Currently, Joyner serves as vice president of the National Association of Social Workers (NASW). She is the immediate past board chair of the Council on Social Work Education (CSWE) and concurrently served on the board of the International Association for Schools of Social Work. Previously, she was president of the Association of Baccalaureate Social Work Program Directors (BPD) and was appointed by the governor of Pennsylvania to the State Board of Social Work Licensure.

Joyner is the first and only African American and the first woman elected to serve on the board of the community bank DNBFIRST. She also is a board member of the Chester County Food Bank and the Dana Farber Cancer Institute's SoulMates Advisory Board in Boston, MA.

The Mit Joyner Gerontology Leadership Award was named in her honor in 2005 by AGE-SW for her leadership for inclusion of gerontology in baccalaureate education. In 2011 she received the BPD Lifetime Achievement Award and the Living Beyond Breast Cancer Founders Award for excellence in leadership and stewardship. In 2012 Howard University honored Joyner with the Dr. Inabel Burns Lindsay Award for her leadership and commitment to social justice. In March 2013 Central State University inducted her into the Hall of Fame as a Distinguished Alumna, and in that same year Joyner was named an NASW Social Work Pioneer.

Joyner co-authored two books, *Critical Multicultural Social Work* (2008) and *Caregivers for Persons Living With HIV/AIDS in Kenya: An Ecological Perspective* (2011), and has delivered hundreds of presentations around the globe. Her most recent scholarly contribution is a co-authored paper related to the Grand Challenges in Social Work Initiatives, "Increasing Success of African American Children and Youths" (with Martell Teasley, Ruth McRoy, Marilyn Amour, Ruby Gourdine, Sandra Crewe, Michael Kelly, Cynthia Franklin, Macheo Payne, John Jackson, Jr., and Rowena Fong).

#### **CRECD** Award

The CRECD Award presented by the Council on Racial, Ethnic, and Cultural Diversity (CRECD) recognizes a doctoral student and a junior faculty member with outstanding scholarship in the areas of racial, ethnic, and cultural diversity in social work education. The award will be presented during the CRECD Connect session. <u>Apply</u> by June 23.

#### 2017 Disability Manuscript Award

The fourth annual Disability Manuscript Award, presented by the Council on Disability and Persons With Disabilities, recognizes scholarship that contributes to knowledge about disability; full participation of persons with disabilities; social, political, and economic issues related to disability and persons with disabilities; and educational material focused on disabilities and persons with disabilities.
