<p>Funding</p> <ul style="list-style-type: none"> <li>Varies based on individuals, groups, councils, commissions</li> <li>Approximately \$5,000.00</li> </ul>	<p>Funding</p> <ul style="list-style-type: none"> <li>Primarily grants; supplemented by CSWE</li> <li>\$35,000-\$40,000.00 per guide</li> <li>Line item in yearly budget</li> <li>Includes: honorariums</li> </ul>

<p>Creation</p> <ul style="list-style-type: none"> <li>Affinity groups</li> <li>Created independently of CSWE staff- including call for participants, meetings, communication                             <ul style="list-style-type: none"> <li><i>However:</i> CSWE involved in monthly updates, revision, marketing/communications</li> </ul> </li> <li>Max 30 pages</li> </ul>	<p>Creation- see <a href="#">Curricular Guide Protocol</a></p> <ul style="list-style-type: none"> <li>CSWE has authority</li> <li>150-250 pages</li> <li>Led by two co-chairs and nine competency chairs</li> <li>Task force members selected by CSWE staff and co-chairs or an open call</li> <li>Task force participants may include: CSWE members, social work professionals and/or interdisciplinary professionals</li> <li>Includes in-person meeting of taskforce and CSWE staff</li> </ul>
<p>Timeline</p> <ul style="list-style-type: none"> <li>Approximately 3-5 months</li> </ul>	<p>Timeline</p> <ul style="list-style-type: none"> <li>Approximately 1-1.5 years</li> </ul>
<p>CSWE Involvement- Limited</p> <ul style="list-style-type: none"> <li>May involve council/commission staff liaison</li> <li>Monthly communication with Program Associate for Curricular Resources and/or staff liaison to discuss timeline, marketing/communication strategy</li> <li>Review content and copyediting, design work</li> </ul>	<p>CSWE involvement- Engaged</p> <ul style="list-style-type: none"> <li>Includes: Vice President of Education, Director of Education Initiatives and Research, Program Associate for Curricular Resources, Meetings &amp; Events, Communications and Marketing, Consultants (Designer, Copyeditor, additional)</li> <li>Organize, facilitate, and correspond with task force</li> </ul>
